I require this contract to be completed and submitted with a non-refundable deposit of 25% of the total expected cost of services for your wedding party. The complete balance for your wedding party will be due on the date of your wedding. Thank you and congratulations! Note: There is a minimum of three (3) people required to book wedding makeup.

Cancellations must be made seven (7) days prior to your reserved date or you will be responsible for the amount of services agreed upon in this contract.

## DEPOSIT

A non-refundable deposit of 25% of the total expected cost of services is required in order to reserve your date and time.

**Photo Release Agreement:**

**BOOKINGS:** To secure a date, a signed contract is required with a 25% deposit due at the time of signing. The deposit is non-refundable and non-transferable. Please be advised, dates and scheduled makeup times will only be reserved when a signed contract and deposit are received.

**DELAYS:** A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if scheduled makeup exceeds allotted time because of client delays. Contract will state the times late fees will begin and the amount charged and will be initialed and approved by client.

**SATISFACTION GUARANTEED:** Makeup will be completed to client's satisfaction, but is not to exceed allotted makeup time. Ample time is given for each makeup upon booking. Acceptance of completed makeup application by client is acknowledgement by client that makeup is done to his / her satisfaction.

**SERVICE LOCATION AND REQUIREMENTS:** Location of service for the day-of-event will be at the discretion of the client, but there are certain requirements the makeup artist needs to complete the makeup applications. A "set up" table/work area needs to be made available for the makeup artist at said location. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly.

**PARKING FEES:** Where parking, valet or toll fees may be incurred, the amount will be included with the final bill and due for payment on the day of the event.

**TRAVEL FEE:** A mileage fee will be charged for locations outside of a twenty (20) mile radius of the city of LaPlace, LA 70068. The amount will be determined at time of inquiry.

**LIABILITY:** All brushes and makeup products are kept sanitary and are sanitized between every makeup application. Makeup products used are hypoallergenic. Any skin condition should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client(s) agree to release the makeup artist (Raven Spencer) from liability for any skin complications due to allergic reactions.

**PAYMENT:** The final balance is due on the day of the event as one payment - no exceptions. The person(s) responsible for the entire balance of payment is the person(s) who has signed the booking contract.

**CANCELLATIONS:** Cancellations can be made up to 60 days before the wedding day without any extra charges. Your 25% original deposit is still non-refundable. If you cancel 30 days prior to your wedding day 50% of the total wedding date rate quote will be charged. If you cancel within 2 weeks or less of the wedding day you will then be charged 100% of the total wedding day rate quoted.
